<b>Description</b>	<p>The use of INSPIRE for environmental monitoring and reporting is a priority use case. Furthermore the INSPIRE Directive implementation has been identified as one of the main vehicles to streamline existing reporting processes in order to make them more effective and efficient. These two initiatives also have similar objectives in terms of facilitating information flow between public administrations (data-sharing) and by also facilitating this toward the general public.</p> <p>To support this development, a concrete action has been defined under the Maintenance and Implementation Work Programme 2016-2020 to develop a rolling, minimum list of spatial data sets that is essential for monitoring and reporting of EU environment policy and that is linked to the Eionet core data flows. As a first step, the Commission agreed to come forward with an initial list of spatial data sets which are explicitly required to be reported under the some 50 pieces of environment legislation that have been screened in the context of the Fitness Check for Environmental Monitoring and Reporting. Based on comments received on this initial list from different communities (MIG, INSPIRE CT, DG ENV Focus Group on monitoring and reporting and Eionet) the priority list of data sets for eReporting v1.0 was prepared.
